



## BERTRAND CORP. ANNOUNCES THE MODIFICATION OF THE EXCHANGE OFFER TERMS ON ITS BONDS MATURING ON 20 DECEMBER 2024

Paris, 10 December 2024

Bertrand Corp. announces the modification of the terms of the exchange offer launched on 24 October 2024 (the '**Exchange Offer**') on the €98,000,000 bonds maturing on 20 December 2024 with a coupon of 4.50% per annum (ISIN: FR0013469285) (the '**Existing 2024 Bonds**') for new bonds maturing on 31 July 2029 with a coupon of 6.65% per annum (ISIN: FR001400RNN9) (the '**Exchange Bonds**').

In addition to the Exchange Bonds, the Eligible Holders will also receive a Cash Consideration as part of their subscription to the Exchange Offer. This Cash Consideration will be fixed and communicated to Eligible Holders who participated to the Exchange Offer as soon as practicable following the pricing of the New Money Bonds (as defined below) and not later than 5:00 p.m. the business day before the date on which the Exchange Offer will expire.

Concurrently with the Exchange Offer, the Issuer is also proposing to issue new bonds due 2029 for cash consideration (the '**New Money Bonds**') and together with the Exchange Bonds, the '**New Bonds**') assimilated and forming a single class of debt securities with the Exchange Bonds. The New Bonds will be assimilated and treated as a single class together with the Original 2029 Bonds for all purposes.

The Exchange Offer period will be extended until 12 December 2024. The result of the Exchange Offer will be announced on 16 December 2024. The exchange of the Existing 2024 Bonds for the Exchange Bonds and the issue of the New Money Bonds will take place on 18 December 2024.

Eligible holders of Existing 2024 Bonds interested in the Exchange Offer are invited to contact their financial intermediaries who must contact BNP Paribas Securities Services, acting as exchange and information agent for the Exchange Offer, no later than 12 December 2024 at 5:00 p.m. (Paris time).
